RULES AND REGULATIONS USER AGREEMENT

In accordance with the VFW by-laws, no VFW 6605 venue rooms will be rented for any political activities and renter cannot use the venue to sponsor any political event.
ABOSOLUTELY NO ALCOHOL SHOULD BE BROUGHT ONTO PREMISES BY THE RENTER OR THEIR GUESTS. If you or any guests are seen sneaking alcohol, the event would be immediately terminated and the signed contract null and void.
Your security deposit of \$350.00 plus of your ballroom rental fees are due at time of booking. They will be deducted from your total- it is just to hold the date. The security deposit will be mailed via up 7-10 days after event. (If you are denied the refund of the security deposit, an explanation will be mailed in place of the check)
*All payments should be written out to the VFW Post 6605.
<u>SECURITY IS REQUIRED FOR ANY PARTY OVER 100 PEOPLE THAT IS</u> <u>SERVING ALCOHOL</u> . We recommend hiring an off duty officer. The sheriff's office can be reached at 478-542-2131.

If serving alcohol, you **MUST** hire our bartenders!! They are \$100 each for the first 4 hours. After that, you will be charged \$15 per hour. You must buy drinks unless you pay a set amount for an open bar. (15% gratuity will be deducted from open bar amount. Once the payment amount is reached, the bar will be shut down unless you decide to pay more)

*** VFW is not responsible for your trash!! Your security deposit will be neld if any trash remains anywhere on premises.
No children under the age of 18 should be left unattended for ANY REASON.
I have read the rules and regulations pertaining to the rental and use of this venue. I agree to abide by rules as stated. I also agree to be personally responsible for all rental fees and any damages that may occur during or as a result of this rental. The VFW has the right to terminate event and/or contract and any time for any reason. The security deposit, I understand, can be kept for any extra fees that arise after the event.
I understand I MUST speak with bartendar before I leave the premises on night of event.
I understand should the function need to be cancelled, VFW MUST be notified no later than 3 weeks prior to function date or all monies paid will be forfeited.
